**Notice is hereby given that the Annual District Meeting of Dartmouth Fire District 2 will be held at the Dartmouth High School, 555 Bakerville Road Dartmouth, Massachusetts on May 8<sup>th</sup> 2023 at 7:00 PM, then and there to act on the following articles.**

**Article 1.** To elect a Moderator to preside over the District Meetings for the ensuing year.

**Article 2.** To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions; or take any other action relative thereto: Prudential Committee three (3) at \$1,800.00 each or \$5,400.00; Town Assessors - three (3) at \$200.00 each or \$600.00 and Moderator at \$200.00 - \$100.00 per meeting.

**Article 3.** To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions; or take any other action relative thereto: Fire Chief \$93,500.00; District Clerk \$ 2,500.00 and District Treasurer \$ 13,000.00

**Article 4.** To see if the District will vote to raise and appropriate a sum of money to fund the following General Expense Accounts: Building Account \$35,000.00; General Insurance \$55,000.00; General Fund \$85,000.00; Health Insurance \$24,000.00; and County Retirement \$55,555.00.

**Article 5.** To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions or take any other action relative thereto: Deputy Chief Stipend \$14,000.00; Full Time Firefighter (2) \$118,328.00 ; Fire Inspector Stipend \$1,200.00 ; Full Time Firefighters Overtime \$10,000.00; Full Time Firefighters Uniform Allowance \$2,000.00; Full Time Firefighter EMT Stipends \$400

**Article 6.** To see if the District will vote to raise and appropriate a sum of money to fund the following Operational Expense Accounts; or take any other action relative thereto: Chief's Account - \$5,550.00; Fire Alarm/Communications \$10,000.00; Fire Equipment - New \$20,000.00; Fire Equipment - Repairs and Maintenance \$12,000.00; Fire Gear and Uniforms \$20,000.00; Fire Prevention/Public Education \$5,000.00; Physicals and Recruitment \$6,000.00; Vehicle Repairs and Maintenance \$20,000.00; Fuel \$10,000

**Total Amount \$108,550.00  
Prudential Committee Recommends 3-0**

**Article 7.**

To see if the District will vote to raise and appropriate a sum of money to fund the compensation of the following positions or take any other action relative thereto: Call Firefighters \$40,000.00; Firefighter Details and Station Coverage, Drills and EMT Stipends \$70,000.00 such that no non-fulltime member shall work more than 100 hours in a 1-month period.

**Total Amount \$110,000.00**

**Article 8.**

To see if the District will vote to raise and appropriate the sum of \$40,000.00 for the reserve fund. This fund is accessible by the Prudential Committee for any extraordinary or unforeseen expenditures that may arise. The remaining balance will close out at the end of the year and convert to free cash.

**Article 9.**

To see if the District will vote to allocate (from the Certified Free Cash Reserve) the following amounts; Physical Fitness Equipment and Gym maintenance \$2,000.00; Reappointment Dinner \$5,000.00

**Article 10.**

To see if the District will vote to raise and appropriate the sum of \$25,000.00 for the stabilization fund. The Stabilization Fund can be used for any lawful purpose and requires a 2/3 vote to appropriate from it.




**Fiscal Year 2024 Tax Levy Request \$799,233.00**




